We note that you have breached the NIMA protocol by not providing a list of at least 10 surveyors when you disagreed with ours.

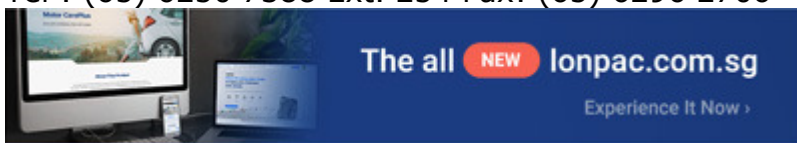
