Accident Sketch Plan

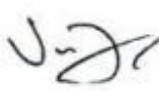

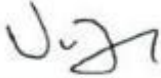
When I went down to check on the other parties, I realized it was a Four Car chain Accident. While four of us was exchanging particulars, Veh E suddenly collide on to Veh D.
