We refer to your email below.

As there is conditions need to clarify pertaining to this case, kindly be-informed that we will not proceed with the repairs.

We are not agreeable for the adjustment of labour charges no.9 is at \$2,750.00. Our repair method is to carry out the spray is as the whole panel. Therefore our charge is as per breakdown below.

Kindly take note our charges per panel is S\$550.00. Over the last discussion on this particular job, we had compromise and agreed the charges from 4.5panels to 3.5panels for such repairs.

1. Rear Bumper – 1 panel
2. Rear Fender RH-1 panel
3. Rear Door RH – 1panel
4. Roof Channel – 1 panel
5. Sill Panel – 1 panel
6. Door Entrance – ½ panel
7. Drain Channel - ½ panel
8. Rear End Panel – ½ panel

The side window has to be replaced as the **locating pin and window rubber moldings** are attached to **window glass** itself. During the dismantling of the quarter glass to facilitate the fender renewal, the mentioned locating pin and moldings will be cut and there isn't any replacement part available. Therefore, it is necessary for the glass to be replace. I attached some photos of the locating pin and parts catalogue illustrations for your reference to justify there is no replacement parts.

I hope that this answers to all your queries. In the event the above is not agreeable. We seek for AIG recommendation or suggestions before we proceed further on the repairs.

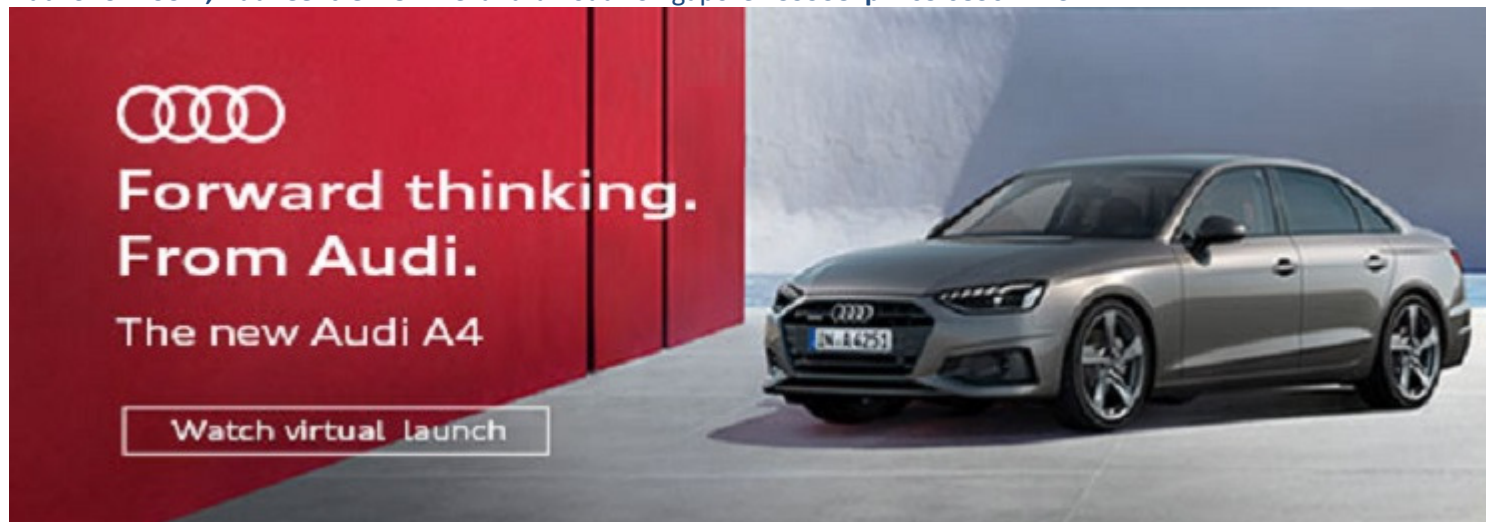
