“Your insured reported he had accidentally hit our client’s vehicle. Based on the scene video we had provided earlier, your insured shows no sign of checking for their blind spot and drove up the slope in a fast speed. Our insured was stationary when he saw your insured going up the slope to give way to him. The accident can be prevented if your insured had slowed down while turning. Since there is a contrary evidence, BOLA is not applicable for this case.

Solely for amicable settlement, we counter propose settlement at 80%.

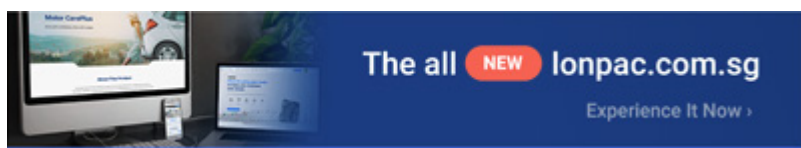
