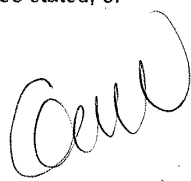

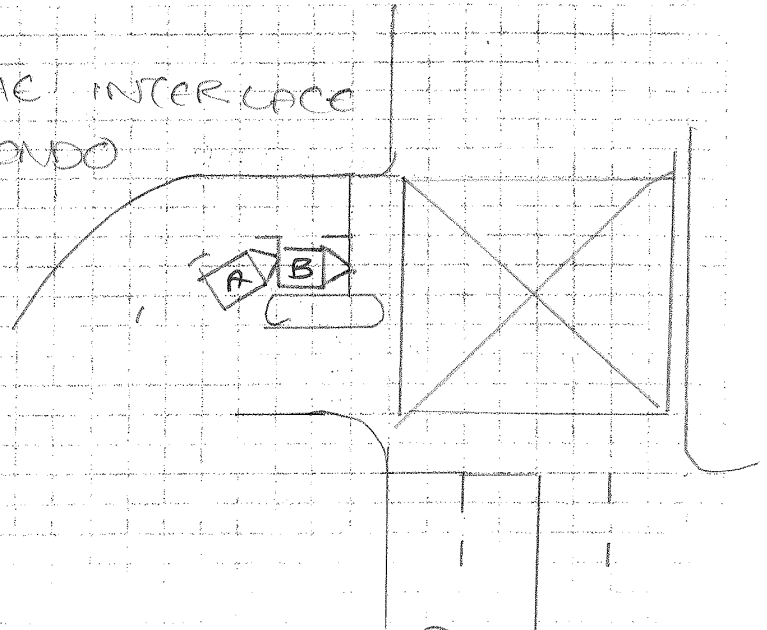

I stop before the traffic light junction and did not noticed my taxi had rolled forward and slight bump the front Trans-Cab SHC5678B rear left portion.

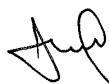
