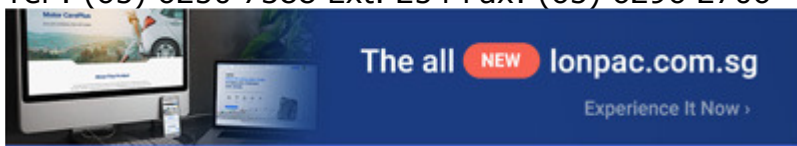
We note that you have breached the NIMA protocol for not providing a list of at least 10 surveyors. Therefore, we hereby expressly reserve all our rights.
