## TERMS & CONDITIONS

- 1. ONLY PERSONS ABOVE 24 YEARS OF AGE WITH MORE THAN 2 YEARS DRIVING EXPERIENCE, AUTHORISED, LICENSED AND SIGNING THIS AGREEMENT MAY DRIVE THE VEHICLE.
- 2. Hirer is responsible for checking and maintaining the engine oil and radiator water level. Veh breakdown repair cost due to no engine oil or radiator water will be bare by the hirer.
- 3. Vehicle is strictly for use in Singapore only and may not be driven out of Singapore without the prior written consent of ABS RENTAL PTE LTD
- 4. All vehicles are fitted with anti-theft device which will response to the RF at the Singapore Customs. Hirer will be fully liable for all cost and charges incurred in event that the immobiliser is being activated at the Singapore Customs. There will be NO REFUND of Unused rental and hirer shall bear the cost of the following charges: i) SGD\$300.00 for towing from Singapore Customs. ii) SGD\$150 for resetting of immobiliser.
- 5. Use of vehicle for illegal purposes (e.g. in connection with theft, drug pedaling or trafficking, smuggling) is strictly prohibited.
- 6. In case of accident, the hirer shall report to the rental office immediately. If there are bodily injuries, a police report must be made within 24 hours
- 7. Punctured tyres, empty petrol tank, flat battery due to negligence, loss of vehicle's key or locked key inside vehicle, by itself does not constitute to a breakdown and that in the event, the Owner's 24 hours Emergency Services is called upon to respond to such occurrence, the Hirer shall bear the cost of such response at SGD\$50 per trip. Punctured and damaged tyres that cannot be reused will be charged accordingly from SGD\$80 \$200 per tyre.
- 8. All vehicles are supplied with petrol and should be returned with petrol level likewise. There will be no refund for excess petrol.
- 9. No refund for early return of vehicle (The hirer shall be liable for excess charges for any late return at rate shown per hour per day). Latest by 6pm.
- 10. Windscreen and windows damages are not covered under insurance (Range from SGD\$300 \$1000)
- 11. Smoking, Transportation of Pets and Durian are not allowed. Hirer is responsible for a penalty of SGD\$300.
