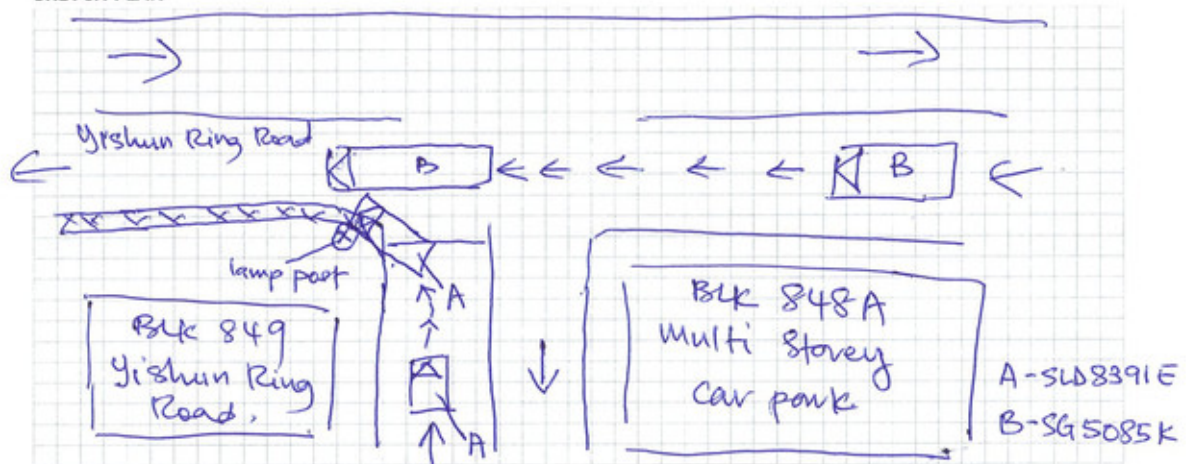

**CONTINUATION OF REPORT**

**Brief Details.**

On 21/10/2020, at about 2.30pm, I was driving out of the carpark with my vehicle SLD8391E towards Yishun Ring Road. While doing so, I saw a SBS bus coming from the right and I wanted to come to a stop. At that point in time, however, I was sneezing, and because of that I accidentally stepped onto the accelerator instead of the brake. This resulted in my vehicle colliding onto the SBS bus that was incoming. The front of my vehicle collided onto the front left side of the SBS bus. The SBS bus vehicle registration number is SG5085K.

Before my vehicle collided, I was actually trying to swerve away from the collision. Hence, after the impact, I was panicking and my vehicle went towards the left as my steering wheel was already turned to the left before the impact. While this happened I panicked again and accidentally stepped onto the accelerator. This time, my vehicle collided onto the lamp post on the left. After this impact, I came down of my vehicle to make a check and noted no one was injured. The damages were seen on my vehicle's front bumper with many dents. The police was also at scene and issued a case card, L/20201021/0074.

I was then instructed to lodge a police report with regards to this incident.

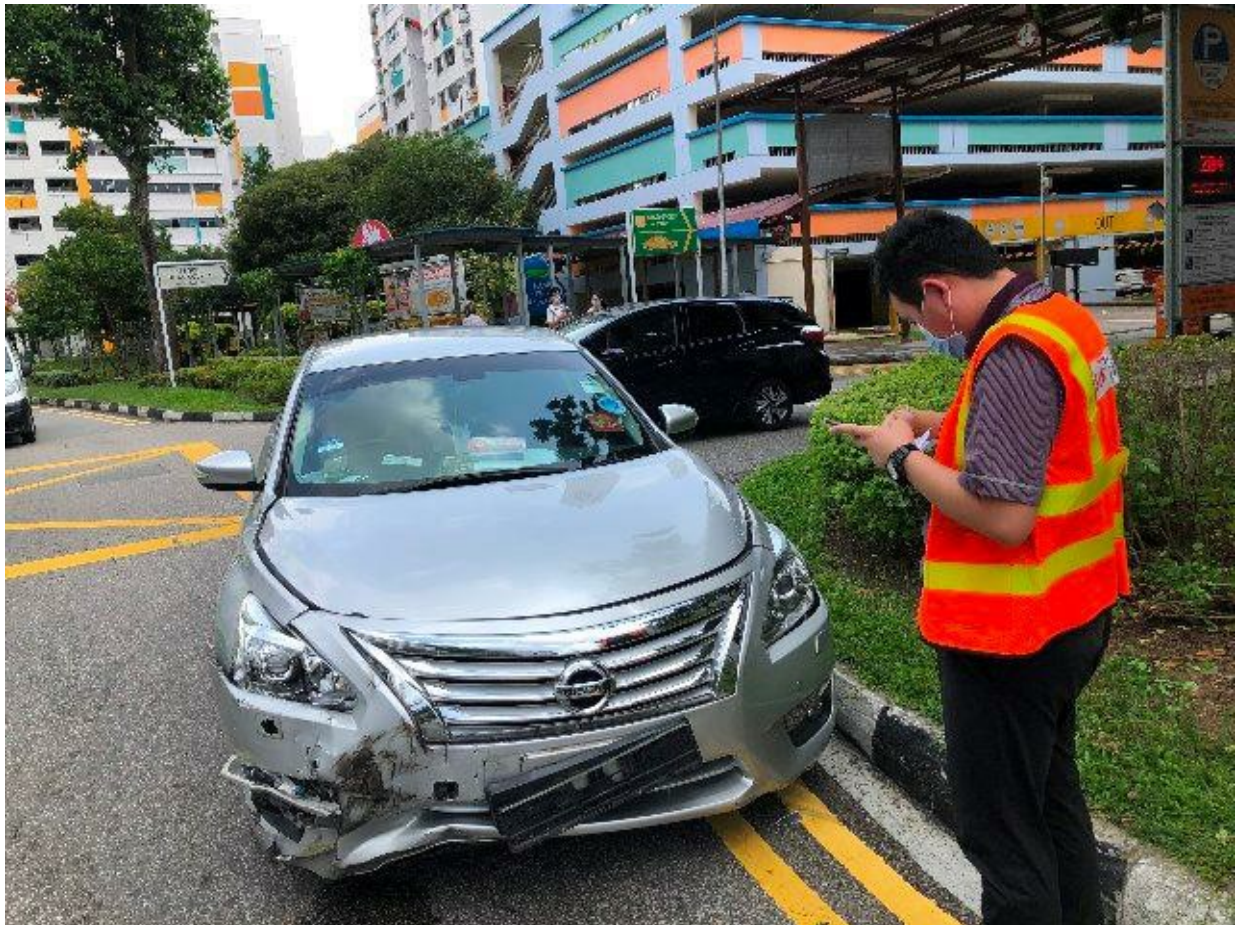
