On 27/10/2020 at about 1545hrs, I was driving my vehicle, SMA980L, along Newton Circus at Lane 3. About a minute later, i felt an impact on my vehicle. I looked to my right and saw a vehicle, SKR1577X, had hit onto my vehicle at my driver's side door. I could not open my door and the owner of the other vehicle had to move her vehicle in order for me to get out of my vehicle. I spoke to the owner of the vehicle, managed to get her particulars and took some photos of the damage.

I do wish to state that i am a delivery driver and i informed my company soon after the accident. I was told to go home after i deliver my current order to have a rest. A few hours after reaching home, my wife who was at home that point of time, told me to visit the doctor as i felt pain on my body. I subsequently went to consult the doctor at Mount Elizabeth(Novena) A&E and was given 5 days MC from 27/10/2020 till 31/10/2020 by Dr Chua Teck Meng Henry. I also wish to state that i have an in-car camera that has recorded the incident. I also informed my car rental company and they informed me to lodge a police report, i subsequently came down to Bukit Merah West Neighbourhood Police Centre to lodge a report using the Self-Help klosk with the help of officer, SGT(3) Balpreet Kaur.
