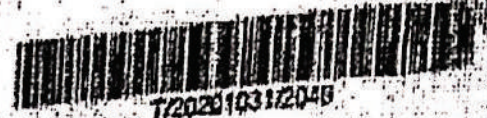

### Brief Details:

On 30/10/2020 at about 03.49pm, while I was driving my taxi (SHD9840S) on my way to pick up a passenger on Choa Chu Kang Drive, just before Choa Chu Kang North 7, a vehicle (GBJ2865B) cut into my lane from the right side. I wish to inform that this is a two lane road, I was travelling on the left lane, while the other vehicle was travelling on the right side. He signaled at the last minute, and cut into my lane abruptly, side swiping the rear left side of his vehicle on the front right side of my vehicle.

I sounded the horn with the attempt to inform him that he had collided into my vehicle, and also to stop him. However, he did not stop and continued driving off. I pursued him, which he had his hazard light switched on without stopping. He then turned into a carpark and finally stopped. I attempted to exchange particulars with him, which he refused, and only gave me his contact number, and vehicle plate number.

I made a check and discovered that there were scratches on my vehicle, and the front of my bonnet was slightly dislodged from the collision. I wish to inform that while I was recording the damages, I saw the other driver taking his phone, pointing his phone's camera in my direction. I am unsure of the purpose of him in doing so.
