SKETCH PLAN

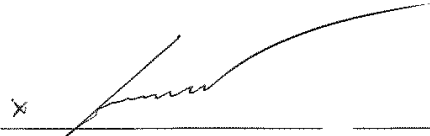

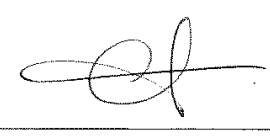

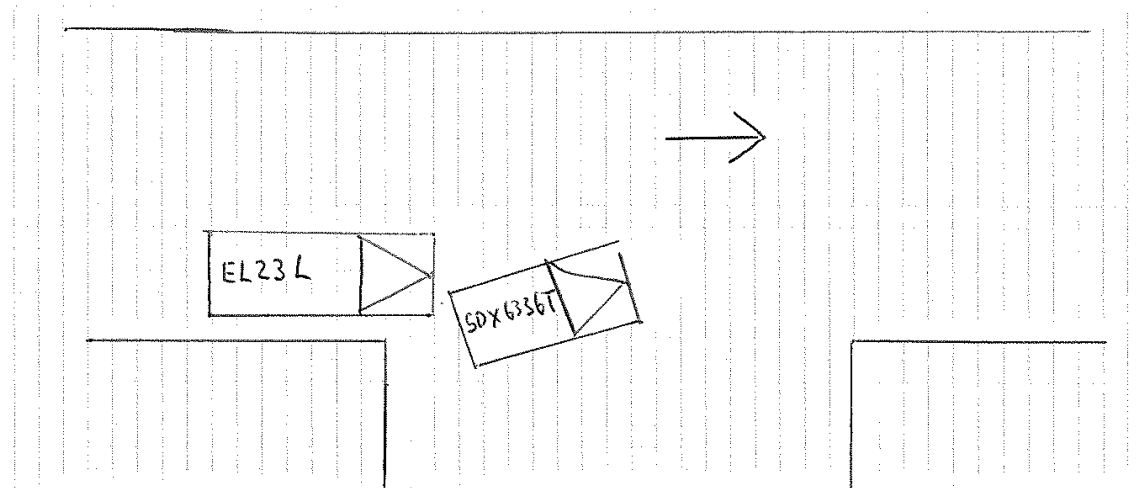
