#### Circumstances of Accident

ON 04-11-2020 AT ABOUT 2130 HRS WHILE I WAS DRIVING VEHICLE A AND WAS MAKING A 3 POINT TURN AT THE SERVICE ROAD OF BLK 402 FAJAR ROAD. WHILST MAKING THE 3 POINT TURN I NOTICE THERE WERE VEHICLES PARKED IN EITHER SIDE OF THE LOT BUT I DID NOT TAKE NOTE OF THE REGISTRATION NO. AFTER MAKING 3 POINT TURN, I DID NOT FEEL ANY IMPACT ON VEHICLE A. I DROVE FORWARD AND PARKED FURTHER UP WHERE IT WAS BRIGHTER. THEREAFTER A VEHICLE DROVE UP TO VEHICLE A. AT THE SAME TIME I SAW MY WIFE WALKING TOWARDS THE VEHICLE A AND I DROVE OUT OF THE PARKING LOT. THE VEHICLE REVERSED AND STOP ALONGSIDE VEHICLE A. THE DRIVER SOUNDED HIS HORN AND I WOUND DOWN THE WINDOW TO CHECK. THE DRIVER, A MALE INDIAN TOLD ME VEHICLE A HAD COLLIDED ONTO HIS VEHICLE. THE DRIVER WALKED TO THE REAR AND MADE A CHECK. THEREAFTER HE LEFT WITHOUT EXCHANGING ANY PARTICULARS. I DID NOT SEE THE DAMAGE ON HIS VEHICLE. BEFORE HE LEFT I TOOK A PHOTOGRAPH OF HIS VEHICLE BEARING REGISTRATION NO. SMQ4938A.

### DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 04-11-2020 at about 2130 hrs while I was driving Vehicle A and was making a 3 point turn at the service road of Blk 402 Fajar Road. Whilst making the 3 point turn I notice there were vehicles parked in either side of the lot but I did not take note of the registration no. After making 3 point turn, I did not feel any impact on Vehicle A. I drove forward and parked further up where it was brighter. Thereafter a vehicle drove up to Vehicle A. At the same time I saw my wife walking towards the Vehicle A and I drove out of the parking lot. The vehicle reversed and stop along side Vehicle A. the driver sounded his horn and I wound down the window to check. The driver a male Indian told me Vehicle A had collided onto his vehicle. The driver walked to the rear and make a check. Thereafter he left without exchanging any particulars. I did not see the damage on his vehicle

### CONTINUATION OF REPORT

#### **Brief Details.**

On 04/11/2020 at about 2130 hrs, at the service road next to Blk 402 Fajar Road, I was driving the company lorry, GBH213L. I was making a 3 point turn at and park at one of the parking lot which was better lit. Subsequently I move the company lorry out of the parking lot and drove towards Blk 402, to pick up my wife. Another vehicle, SMQ4938A whom drove past my vehicle from the opposite direction, I did not notice or hear anything amiss. The said vehicle sudden reverse and park parallel to the company lorry before honking me.

I then wind down the driver side window and the other driver, a male Indian, claim that the company lorry had collided against his vehicle. Both the other driver and I alight from our vehicle. However the other driver did not exchange particulars or contact number with me. The other driver also did not inform me which part of his vehicle was damage. The other driver just walk to the rear of the company lorry before driving off. I was not able to check the other vehicle for any damage. I did check on the company lorry, but did not observe any damage.

On 06/11/2020 I was informed by the company management that the other driver had lodge a traffic accident report, claiming that I was involved in a hit and run. I then proceeded to lodge a report with the insurance company whom advice me to lodge a Traffic Accident report.

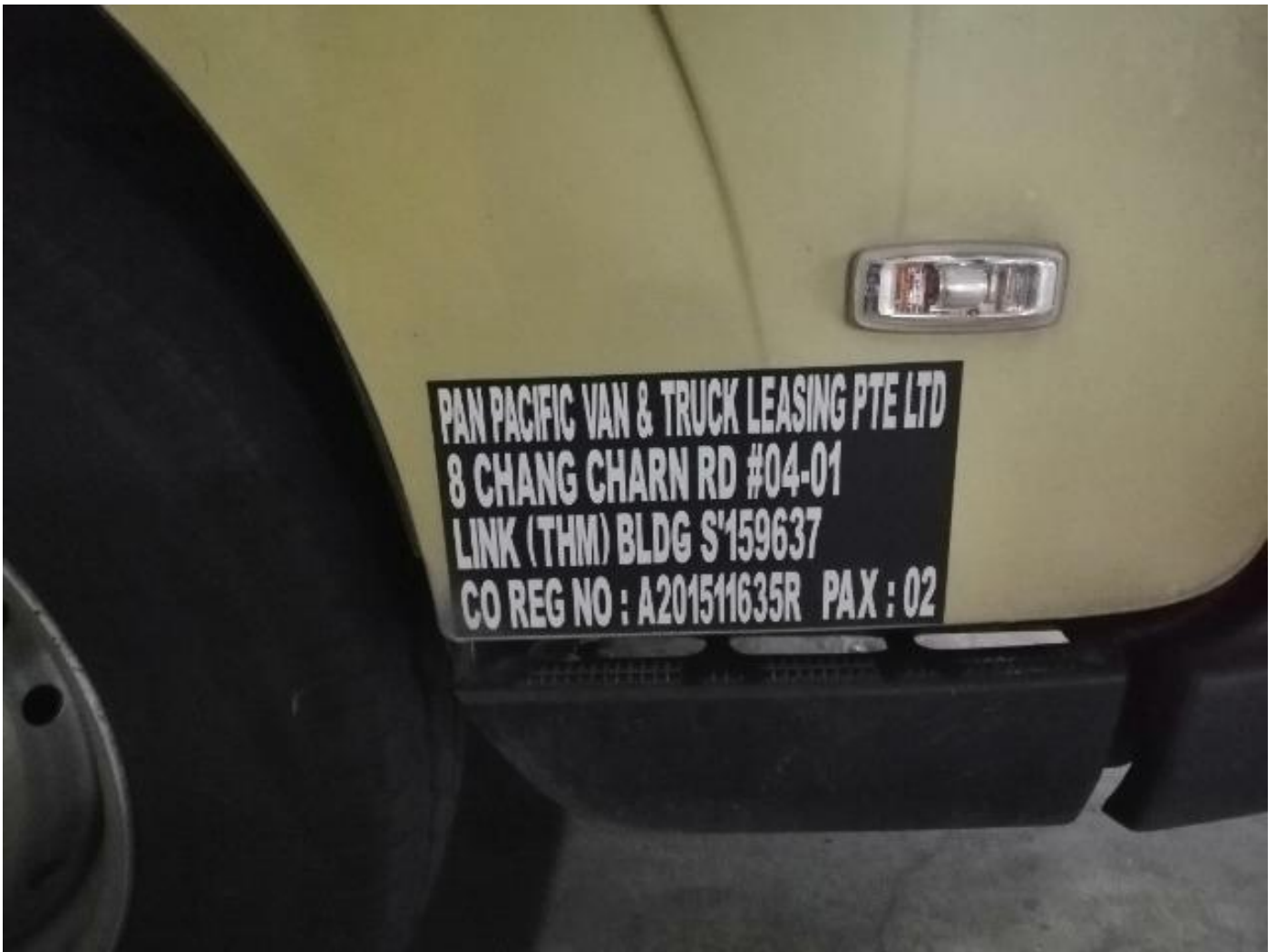

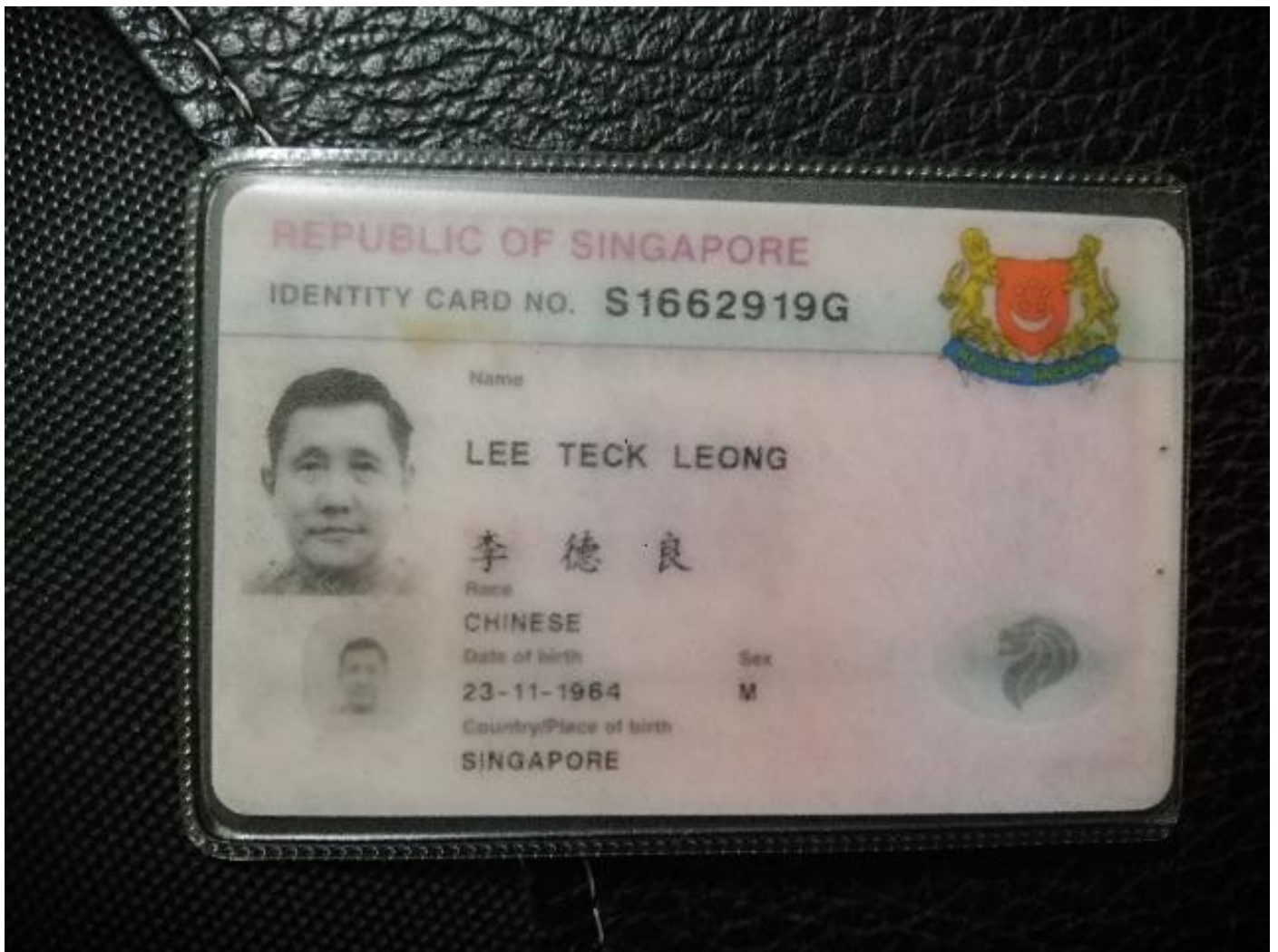
