#straightroad Changing lane & Moving in own Lane SMT5618B SLR161G WSV20001834 Accident_Description SLR161G was on the right lane waiting behind a car wanting to make a right turn into East Coast Drive. I was on the left lane and I signaled to change to the right lane as I needed to make a right turn into Siglap Road and take the ECP. When the front car turned right SLR161G went straight and that was when the side swipe happened. I came out of the car to inspect and found there were no damages to both cars. The driver of SLR161G did not exit her car to inspect. Since there were no damages I assured her that I would not make a claim. The whole time the driver of SLR161G did not exit her car I spoke to her through her car window. I drove off after ensuring she was not hurt both cars were not damaged and after we both agreed not to make any claims against each other. I did not want to prolong discussions with the driver of SLR161G as my wife and three year old granddaughter were waiting in the car and I did not want to hold up traffic unnecessarily. Any claim made against me for this incident would be unjustified as there were no damages to both cars.

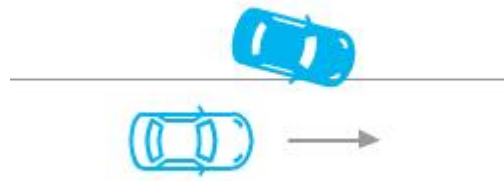
