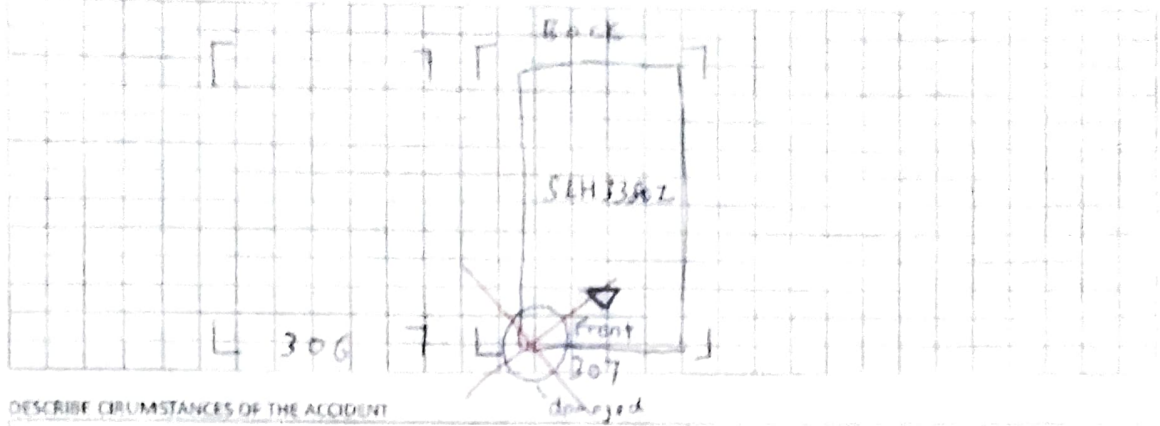

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

My car, SLH3380Z, was parked in my residence's basement car-park lot #307 (Westwood Residences E.C.) since 9am on 5/11/2020.
