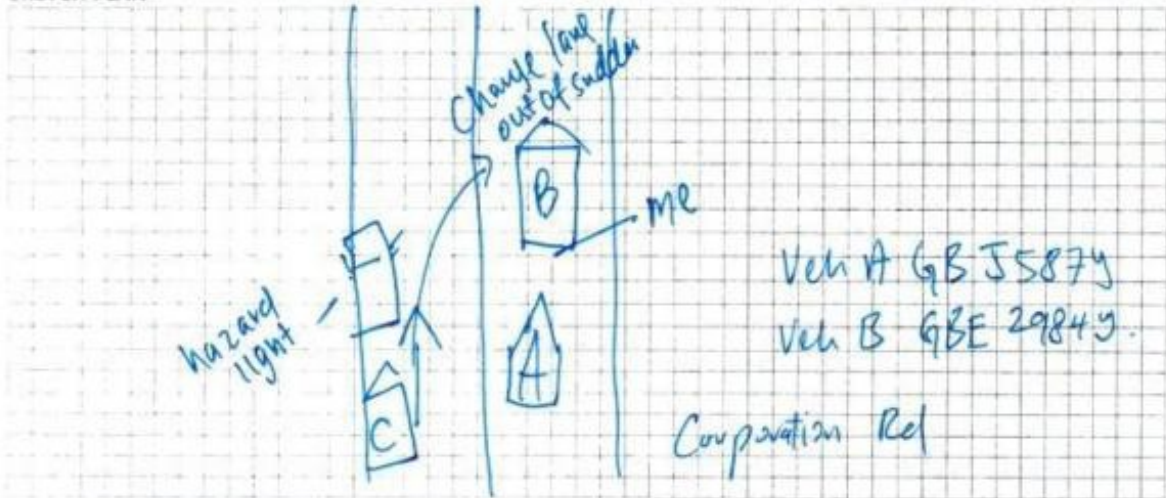

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

ON 9 NOV 20 at 6.30pm I Ahmad Tanthe bin Abdullah, SA039477J driver of vehicle GBJ5874. I was on the right lane along Corporation rd with vehicle GBE 29843 driving in front of me. Driver of that vehicle had suddenly jam break to avoid collision with another car in front of him who had turned into the right lane as on the left lane another vehicle had his hazard light on. I jammed break upon noticing gbe 29843 had jam break. However, I did not have enough time to avoid hitting his vehicle. Driver GBE 29843 did admit that he had accelerated and jammed break to avoid the car in front of him.
