Circumstances of Accident

WSVC20001769 Accident_Description On 4 November 2020 at 1.05pm I was driving from Yishun Ave 11 towards Yishun Central. The accident happened in the T-Junction where I was following behind the third party vehicle. The third party vehicle stopped for pedestrians to cross the road. Unknowingly my vehicle seems to go to near to the third party vehicle and there was a very slight impact. Thus we alight our cars to check and exchanged particulars. Apparently there is no noticeable damage on the front of my car. However it appeared that there are some minor scratches on the rear bumper of the third party car. The scratches do not seem to be caused by the "collision". With the benefit of doubt I have offered the third party two hundred dollars for private settlement but was declined by him. The third party decided to send his car to his designated workshop for damage assessment. Subsequently he might claim against me. In sum my car did not suffer any noticeable dents and scratches.

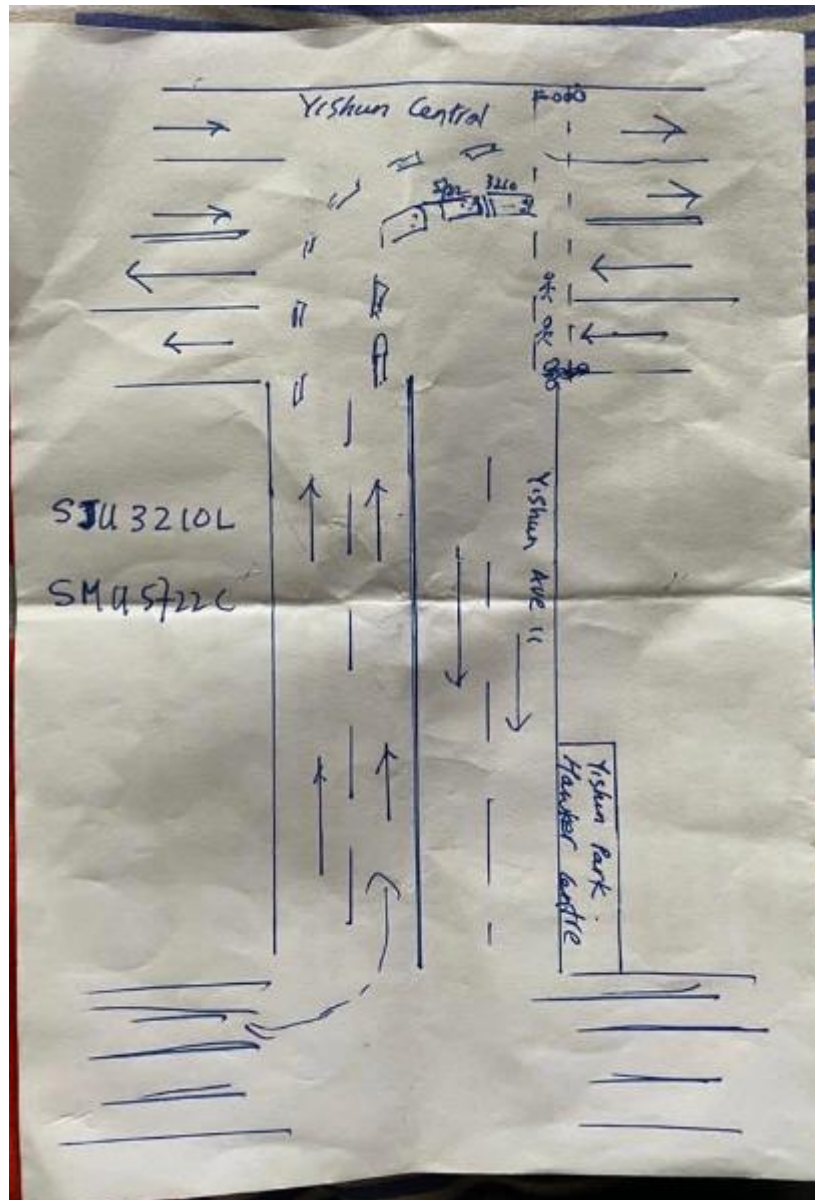

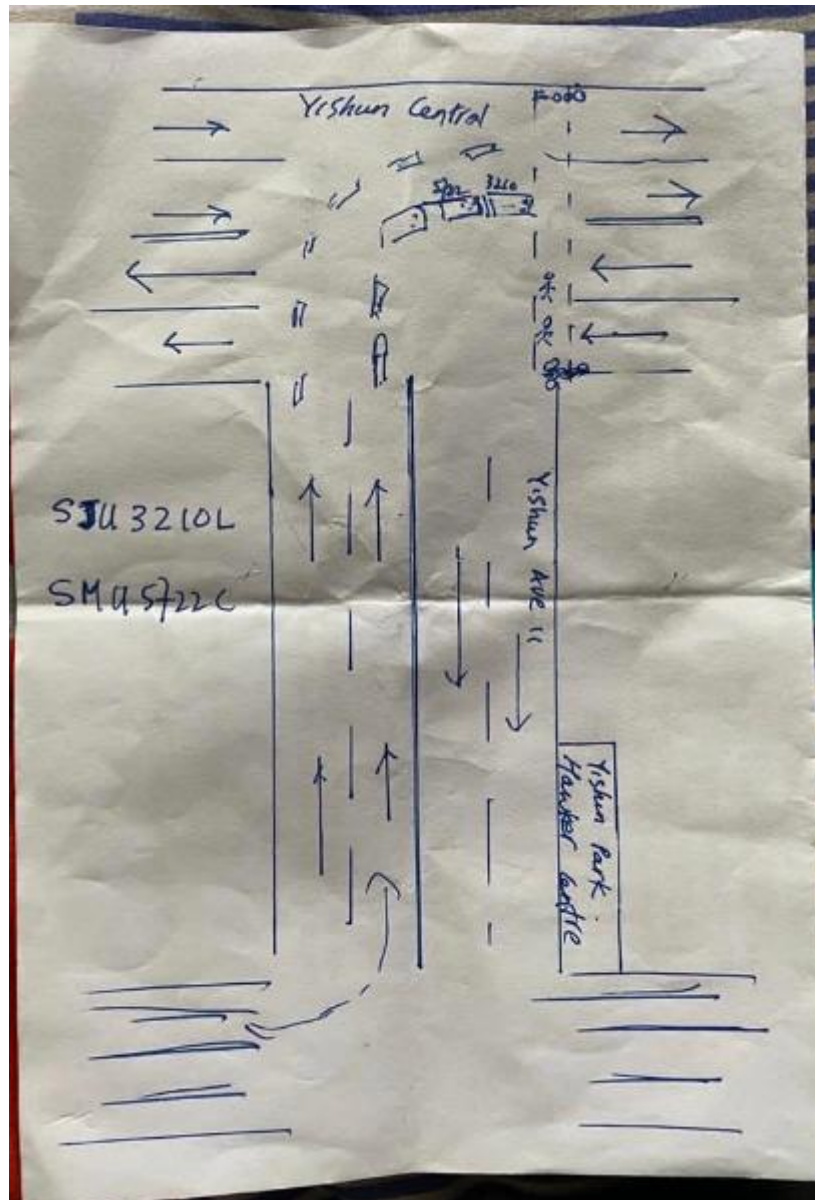
