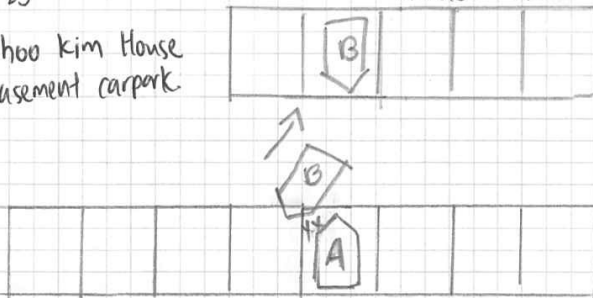


Accident Sketch Plan Pg. 1
