We are pleased to inform you that the Court has appointed your Mr. Muhammed Rasul as the single joint expert ("SJE") surveyor for the abovecaptioned matter and to conduct an independent assessment in respect of the cost of repairs to **SKJ 8921G.**

In this regard, we would be most obliged if Mr. Rasul could conduct a <u>physical re-inspection</u> of the Plaintiff's vehicle no. **SKJ 8921G** with a view towards rendering his SJE report.
