Brief Details.

On the 28/10/2020 at about 2150hrs, I was driving 3 of my friends home on my vehicle SMC5724S after we had supper at Serangoon Garden on Sengkang East Drive towards Punggol at the T-Junction between Sengkang East Drive and Sengkang East Way I was heading straight as the light was green I was on the 3rd lane which is on the left side. I had the right of way as the traffic light was showing green on my side but when I was half-way through the T-junction so I saw one a white color car SLA315U driving at the opposite direction turning right into Sengkang East Way. I did check before moving across the T-junction that there was no car turning into Sengkang East Way.

I noticed that instead of decelerating to make a turn into Sengkang East Way, He in fact accelerated when he was making a turn which caught me off guard. As such, the head of his vehicle collided with the right front side of my vehicle however my car was moving straight so the white color car was dragged along which caused damage to the rear right side of my vehicle too. The impact causes my right front headlight to shatter and scrap of the side near towards the right front headlight and caused my right rear door lower part to be dented and my rear bumper also on the verge of falling off. Both doors on the right side of my car is unable to open which was caused by the impact. My car plate also dropped due to the impact and there is also a crack on my windscreen. Only the head of the other vehicle was damaged, the impact caused his car plate to drop, the front was scrap off and his front right headlight dropped off.

Subsequently, the driver of SLA315U he drove into Sengkang East Way and came down off his vehicle to make a check on us to see if we were ok and apologies that he bang my car. I also shifted my car to one side after the T-junction parallel to the double yellow line Sengkang East Drive. After which I phoned for the police as such TP officers came down to scene together with the ambulance. I was attended by the medic together with one of my friend and we were conveyed to the nearest Hospital which was Sengkang

General Hospital:

We were admitted on the 28/10/2020 and were discharged on the 28/10/2020 I was discharged at about 0400hrs having 5 days MC from 28/10/2020 to 01/11/2020 and my friend was discharge at about 1000hrs having a 4 days MC from 28/10/2020 to 31/10/2020. My rib area was swelling and tender as well my left wrist and for my friend she was diagnosed with slight concussion, her left eyebrow and her right leg was swelling due to the impact.

I was informed by TP that my case was handle by IO Daniel and they told to make police report regarding this matter while waiting for the IO to investigate.
