We have contacted insured (MR TAN) via email and informed him that liability is not in his favour as his driver was reversing and collided with Third Party who was stationary at the main road.

Mr Tan replied to the email and wants to highlight that TP stopped in the middle of two way lane (in front of his house) instead of side of the road to alight a passenger, which he thinks is not right for TP to do that. Also during this accident, there have been almost no damage on my his except some blue paint sticking on the bumper and was easily rubbed off with some polish cream. He hope these 2 info can help with the negotiation.

In view of both parties report and OI video, we are of the view that liability is not in our insured's favour. Based on OI video, TP have stop there for a while and there is still a distance for OI to check and stop reversing to avoid the collision. As for damages, the impact caused a dent on TP left rear bumper which is consistent to the accident.
