Brief Details.

On 12/09/2020 at around 1705hrs, I was driving along the second lane from the left, along BKE towards Woodlands, near Exit 8 where there is chain collision, whereby I am the last vehicle. I was on duty as ICA Officer, driving a ICA department van. My van's front bumper was damaged from the accident. Police officers then came and gave me a case card to lodge a police report. I have already informed ICA on this matter. In the chain collision, the Suzuki was the first car, followed by Mercedes then Mazda then my van. It was drizzling during that point of time and the floor was wet too.

ACCIDENT SKETCH PLAN

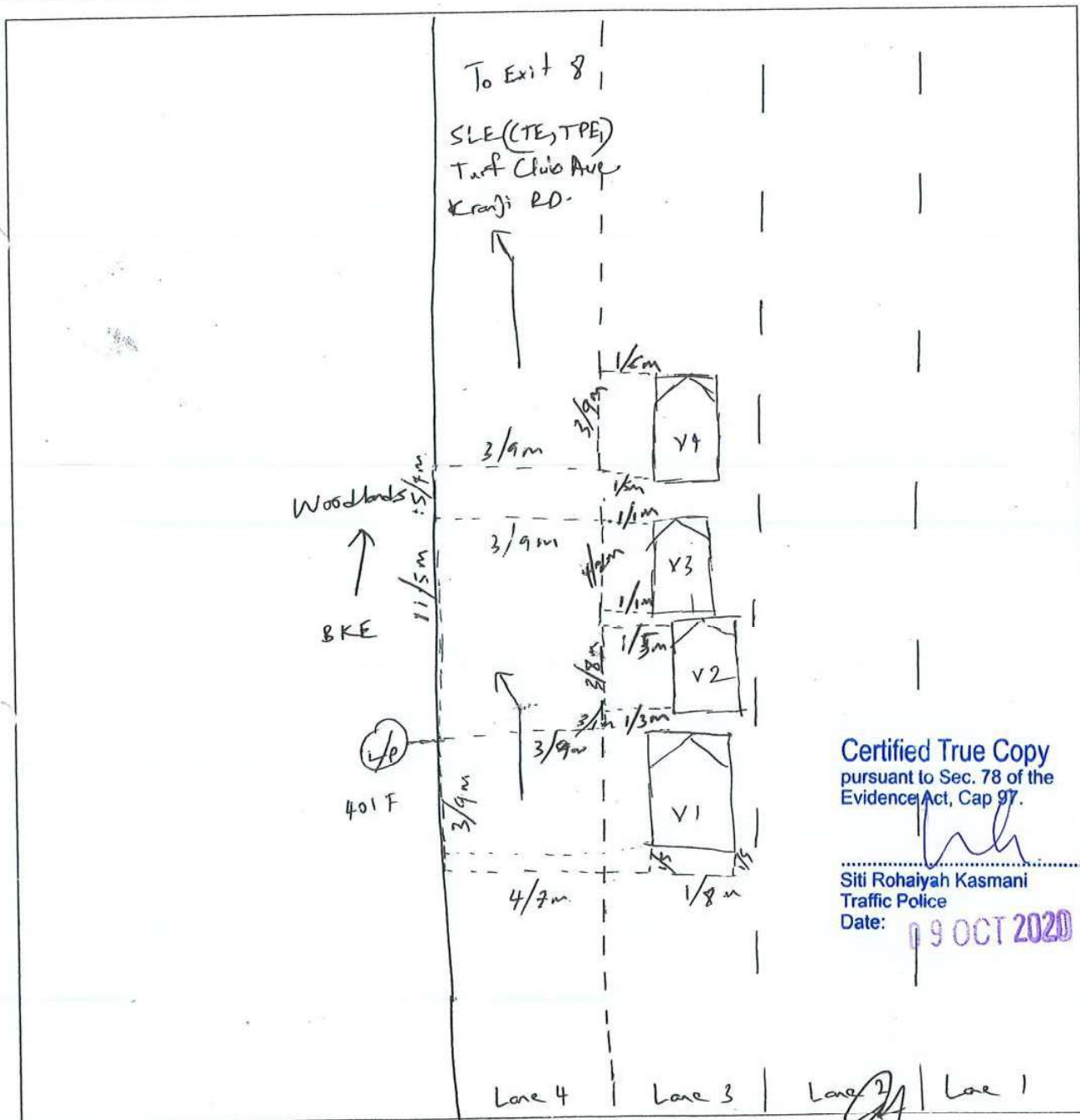
