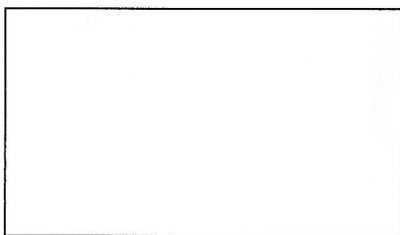

ACCIDENT INVOLVING GBE5677P (OI) & SKT7479X (TP) ON 07/11/2020

We refer to the above matter.

TP reported that he was driving along airport road towards KPE, after the conversion, our insured driver cut into his lane and grazed onto his rear.

OI reported that while crossing the traffic junction, TP crossed over to lane 2 and collided with him inside the yellow box.

In view of both parties report and video, we are of the view that liability is not in our insured's favour. Before the traffic junction, there was 4 lane in total, TP was on 2nd lane from left, while our insured driver was on the 3rd lane, the 4th lane is for vehicles turning right.

After the traffic junction, TP was still travelling on 2nd lane. Our insured driver should travel on the 3rd lane but was seen trying to cut into 2nd lane where TP is.

Kindly let us have your view/comments on the liability after reviewing the matter in order for us to get back to OI
