**Brief Details.**

On 06/11/2020 at about 1600hrs, traffic police came to my house and informed that my husband namely, Jagan S/O Ponusamy had passed away in a fatal traffic accident.

The traffic police told me that on 06/11/2020 at about 1250hrs, my husband was involved in a fatal accident involving his motorcycle plate number FBK5719X and another motorcycle plate number FBN7076M along Hougang Avenue 4 towards Lor Low Koon. My husband was conveyed to Sengkang General Hospital and was declared dead at Sengkang General Hospital by Dr George Paul on 06/11/2020 at 1405hrs due to Valvular Heart Disease reference Death registration number 327481J.

I was told by the traffic police to lodge a report after I had settled all the funeral arrangements. As such, I came to lodge a report as requested. That is all.
