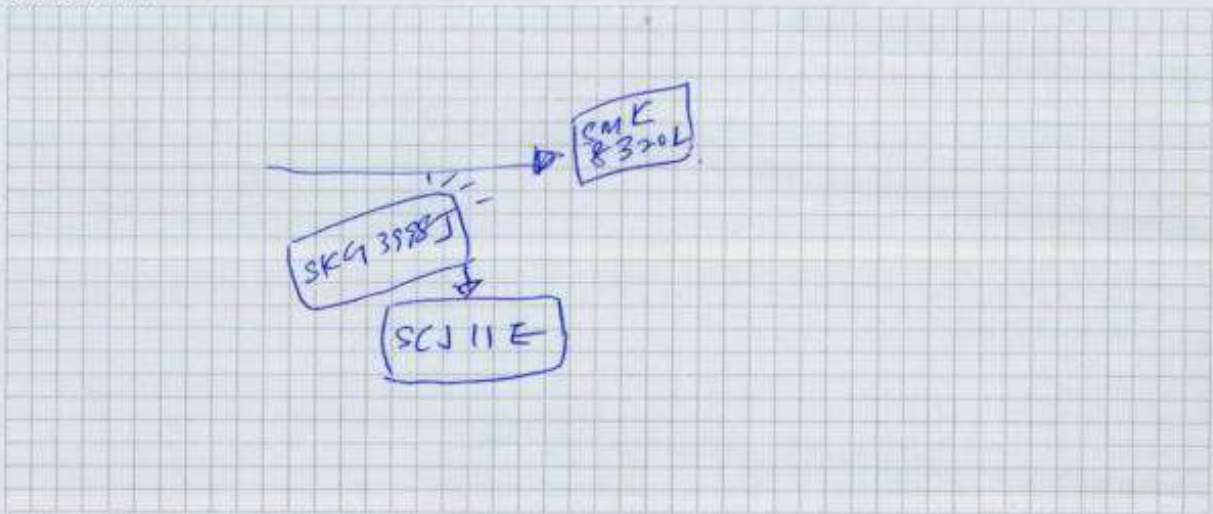

ACCIDENT STATEMENT

Date of Accident : 11 Nov 2020

Vehicles involved:

1. SKG3998J Audi Grey A3 – Belongs to me (Mervin Phng Hwee Leng – HP 9862 5072). I have a passenger in the car at point of accident Lim Mei Xuan Elia – HP 9736 8087)
2. SCJ11E White Mercedes on my right was stationary (Tan Wee Pheng NRIC 1245084B - HP 9726 9398) - alone
3. SMK 8320L White BMW 216 not in the picture was on my left as he drove to park somewhere nearby as not to cause traffic jam (Jonathan Chan Tuan San, NRIC 8536783H – HP 9728 0825) - alone

I was driving along Queensway and signaled to filter to left to exit to Jalan Bukit Merah. Road condition and weather were good and when I filtered to the left suddenly a car (car no SMK 8320L driven by Jonathan) on my right hit me on my left and caused my car to move to the right and hit the stationary car (SCJ11E) on my right. As not to cause traffic jam, Jonathan drove the car further down the road and came back to pass us his IC and told us he was the guy that knocked our car.
