#### Circumstances of Accident

I WAS MAKING A RIGHT TURN OUT OF MY CONDOMINIUM (FORTUNE JADE) TO DUNMAN ROAD (HEADING TOWARDS OLD AIRPORT ROAD). I WAS STATIONARY AT THE EXIT OF THE CODOMINIUM AND CHECKED FOR TRAFFIC FROM BOTH DIRECTIONS I DID NOT SEE ANY TRAFFIC AND PROCEEDED TO MAKE THE TURN. WHILE I WAS MAKING THE TURN, A CYCLIST ON AN E-BIKE (GOING STRAIGHT ON DUNMAN ROAD IN THE DIRECTION OF JOO CHIAT ROAD) APPEARED IN FRONT OF MY VEHICLE. BY THIS TIME I WAS ABOUT TO ENTER INTO LANE 1 (DUNMAN ROAD HEADING IN THE DIRECTION OF JOO CHIAT ROAD). I BRAKED BUT STILL MADE CONTACT WITH THE REAR WHEEL OF THE E-BIKE. THE E-BIKE TOPPLED TO THE SIDE WITH THE CYCLIST (A GRAB FOOD DELIVERY RIDER NAMED JEFFREY FONG). I WENT TO CHECK ON THE CYCLIST AND HE INDICATED HE WAS NOT HURT. I HELPED HIM PICK UP HIS ITEMS THAT HAD FALLEN FROM THE DELIVERY BAG. THE CYCLIST WHEELED HIS E-BIKE TO THE SIDE OF THE ROAD (NEAR THE EXIT OF FORTUNE JADE). I THEN REVERSED MY CAR BACK INTO THE CONDOMINIUM SO I WAS NOT BLOCKING THE ROAD. I SPOKE TO THE CYCLIST WHO CHECKED HIS LEG, PHONE AND BIKE. HE INDICATED HE WAS UNHARMED. WE EXCHANGED NUMBERS.

## Brief Details:

I was making a right turn out of my condominium (Fortune Jade) to Dunman road (heading towards Old Airport Road). I was stationary at the exit of the condominium and checked for traffic from both directions. I did not see any traffic and proceeded to make the turn.

While I was making the turn, a cyclist on an e-bike (going straight on Dunman Road in the direction of Joo Chiat Road) appeared in front of my vehicle. By this time I was about to enter into lane 1 (Dunman Road heading in the direction of Joo Chiat Road). I braked but still made contact with the rear wheel of the e-bike. The e-bike toppled to the side with the cyclist (a grab food delivery rider named Jeffray Fong). I went to check on the cyclist and he indicated he was not hurt. I helped him pick up his items that had fallen from the delivery bag. The cyclist wheeled his e-bike to the side of the road (near the exit of Fortune Jade). I then reversed my car back into the condominium so I was not blocking the road. I spoke to the cyclist who checked his leg, phone and bike. He indicated he was unharmed. We exchanged numbers.
