**Brief Details.**

On 17/11/2020 about 10:30pm, SDL186L was on the right lane at junction of Marine Crescent turning into Marine Terrace (see photo - lane allows go straight and turn left). SGW3462B was on the left lane. SDL186L signaled to turn left (see photo - orange left turn light is on). Traffic light turned green and both cars turned left. Suddenly there was a loud sound on my front left. I stopped my car and got out and saw that the right front of SGW3462B has knocked into the left front of my car. The driver of SGW3462B got into his car and reversed. I ran forward to stop him and reminded that vehicles are not supposed to be moved immediately after an accident.

I started to take photos. The photos indicate that SGW3462B either tried to go straight on a left turn only lane. Or made an overly wide left turn. The space on the left of SGW3462B is huge. Another car can easily pass through. The back wheels of SGW3462B are across the lane divider.

From the photos, it is clear that after turning left, the car on the left lane (SGW3462B) has to give way to the car on the right (SDL186L) as the two lanes merge into one. This indicates that SGW3462B failed to give way as required by traffic rules and instead knocked into SDL86L.

I did not have time to take pictures of SGW3462B as the driver insisted that he is in a rush and drove off before i could take more than the one picture of it attached here. I did get to see that SGW3462B had only some scratches. The driver insisted that a customer had been calling and chasing him all the while. From the photo, there is a police camera at the side of Block 55. Hopefully, it has footage to show whether the driver of SGW3462B was using the phone, the paths/direction taken by both cars, the angle of SGW3462B reversing, etc.

I did not file a police report as there was no injury to anyone. You can see in the pictures that the driver of SGW3462B is standing fine. He also said that he is fine. I am filing this police report now because the Audi personnel informed me this week that the driver of SGW3462B somehow has a 3 day MC and I therefore need to file this report. When filing this report online, the system allowed me to proceed only if I click "Yes" to injury. If I click "No" as per what actually happened, I'm instructed to file a claim with accident reporting centre/insurer only.

I have photos exceeding 2MB. I do not have car camera video of the accident. The accident reporting centre staff helped me to locate and take out the SIM card. When he connected it to the PC, he said that footage had unfortunately been overrode. The SIM card is with the reporting centre.

If there are any police cameras in the area, may I please appeal for the police's help to view the footage and (if appropriate and if allowed) for the police to send the relevant footage to the insurance company. I appreciate any assistance possible and apologise for the inconvenience and workload.

Note: I've attached 14 photos. But I'm retired and not uptodate with IT and am not sure whether all 14 were uploaded properly. If you find less than 14 photos, please let me know and I'll re-provide. Thank you.
