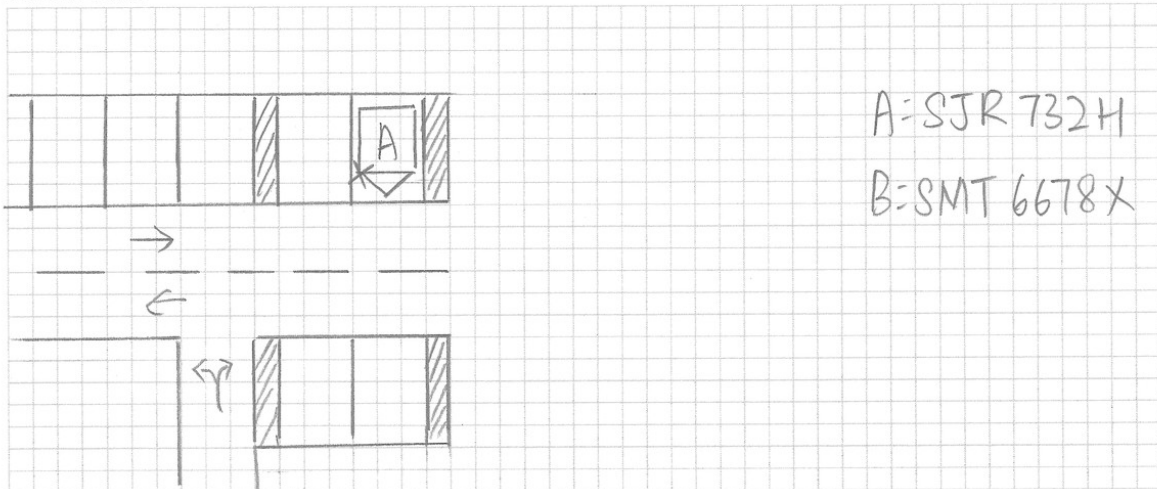

**Brief details.**

Our car was parked in our residential basement carpark since last night, and this morning we discovered a hit and run. Front right corner had been badly damaged, looking like the neighbouring car on the right turned out too sharply while driving out of the lot next to us and forcefully hit our stationary car. We parked our car on 21 Nov at around 10pm plus, and was not moved since. This morning (22 Nov) at around 11.40am or so, we discovered the damage. By the time we discovered the damage - the lot on the right was empty. Our car's front right body was badly scraped, bonnet dislodged and headlight smashed. Impact was great to the extent the car was force shifted to the left. Front right wheel force-turned. We had parked it straight the night before. Paint marks left on our car's damages looked dark
