Circumstances of Accident

I WAS PARKED STATIONARY AT MSCP LEVEL 4 OF PEOPLE'S PARK CENTER AND I WAS INSIDE THE VEHICLE PREPARING TO GO FOR LUNCH. SUDDENLY, I FELT AN IMPACT. VEHICLE B FROM MY RH SIDE EXIT FROM THE CARPARK LOT AND ACCIDENTALLY COLLIDED ONTO THE FRONT RH PORTION OF MY VEHICLE AND CAUSED DAMAGES. VEHICLE B DID NOT STOP DIRECTLY AND DROVE AWAY. I CHASED HIM AND MANAGED TO STOP HIM. VEHICLE B ALIGHTED AND TALKED WITH ME, AND PASSED ME THE NAME CARD AND GOT ME TO CONTACT HIM. INITIALLY, VEHICLE B WISH TO COMPENSTATE ME. HOWEVER, WE CANNOT COME INTO AGREEMENT WITH THE REPAIR COST. THEREFORE, WE DECIDED TO PROCEED WITH INSURANCE CLAIMS.
