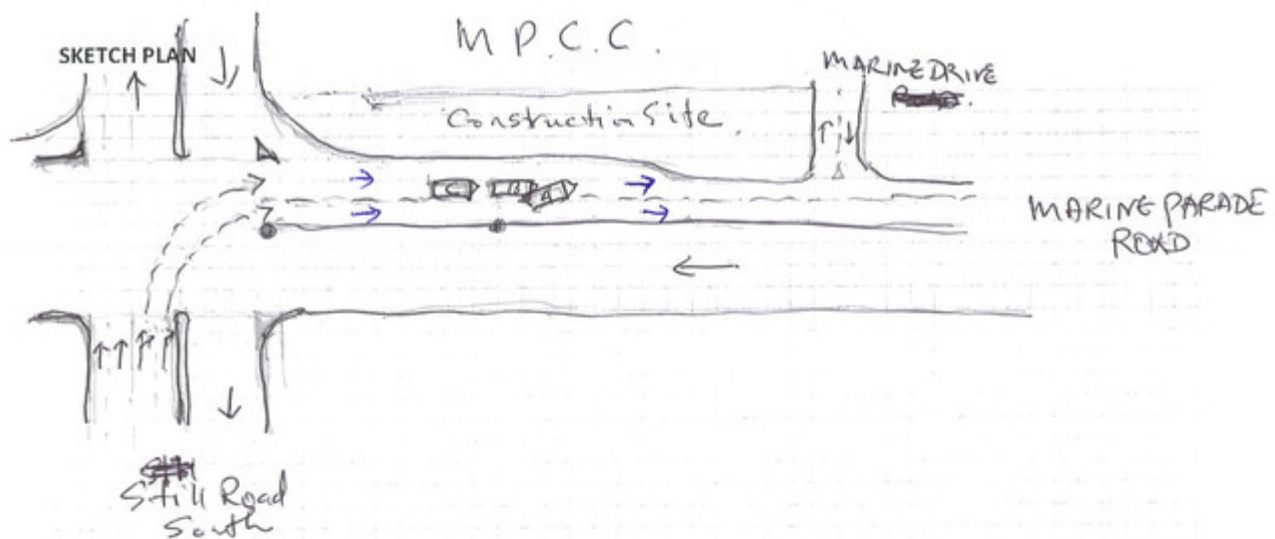

Brief Details.

On 21/11/2020 at about 0930hrs, I was driving along Still Road South towards Marine Parade Road. I turned right to filter into Marine Parade Road, I saw the blue taxi SH9647H at my left turning to the right and hit onto my car's left side. So we stopped after the collision. A silver car SMR6934S which was behind us also hit onto the taxi.

We all stopped at the road side and got off to check for damages. My car's left side passenger doors are dented and scratched, the taxi's front right near to bumper area was dented and scratched, the rear bumper had light scratches. The silver car had light scratches on the front bumper.

We were all fine at that time, no one was injured and no police or ambulance attended. So we just exchanged partial particulars and we left. On 24/11/2020 at about 0900hrs, I sent my car to workshop, I was then being notified by the insurance that the driver of the taxi claimed to be injured from the accident.
