Brief Details.

On 29/10/2020 at about 0850hrs, I was riding my motorcycle FBK8826A along Yishun Avenue 5 towards Sembawang Road. I was travelling on the right of 2 lanes and the traffic was clear. I was approaching the carpark entrance of Blk 701 Yishun Avenue 5, when suddenly a car SMR9973J, came out of the carpark and drove straight into my lane. I applied emergency brakes but was not able to avoid the car. I collided into the front right portion of the car and I fell off my motorcycle.

I was later conveyed to Khoo Teck Puat Hospital by ambulance. I was given Hospitalization Leave of 2 days from 29/10/2020 to 30/10/2020. On 30/10/2020, I went to National University Hospital to seek further treatment. I was warded for 7 days and had underwent surgery. I had suffered broken and fractured ribs and internal bleeding. I was given 32 days of Hospitalization Leave from 30/10/2020 to 30/11/2020. I managed to retrieve a video footage of the accident from social media and have forwarded the video to Traffic Police.
