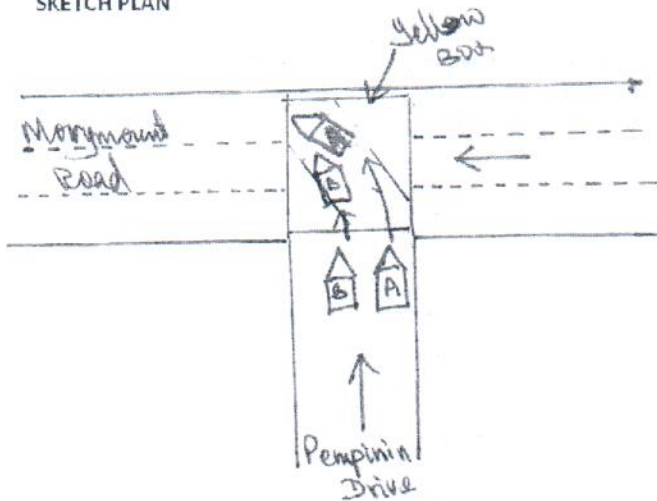

SKETCH PLAN



and collided onto my vehicle left rear side


