The following are our comments:-

- (a) The Vehicle Caught Fire. The Cause Of Fire Probably Due to faulty electronic components. (Details see photographs enclosed)
- (b) In view of this, we are of the opinion that it would be **unsafe** to proceed with the repairs due to extensive damages on the chassis under the category of **the section 2 of THE ROAD TRAFFIC ACT on THE MOTOR VEHICLES** (CONSTRUCTION AND USE) (AMENDMENT NO.2) RULES 1989, that:

no vehicle shall be fitted with a replacement chassis or any body part where the chassis is an integral part of the vehicle. and we therefore recommend it to be written off as "Total Loss"
