SKETCH PLAN

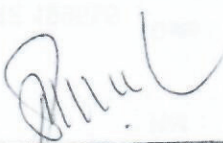

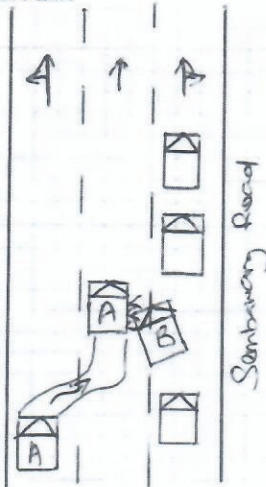
