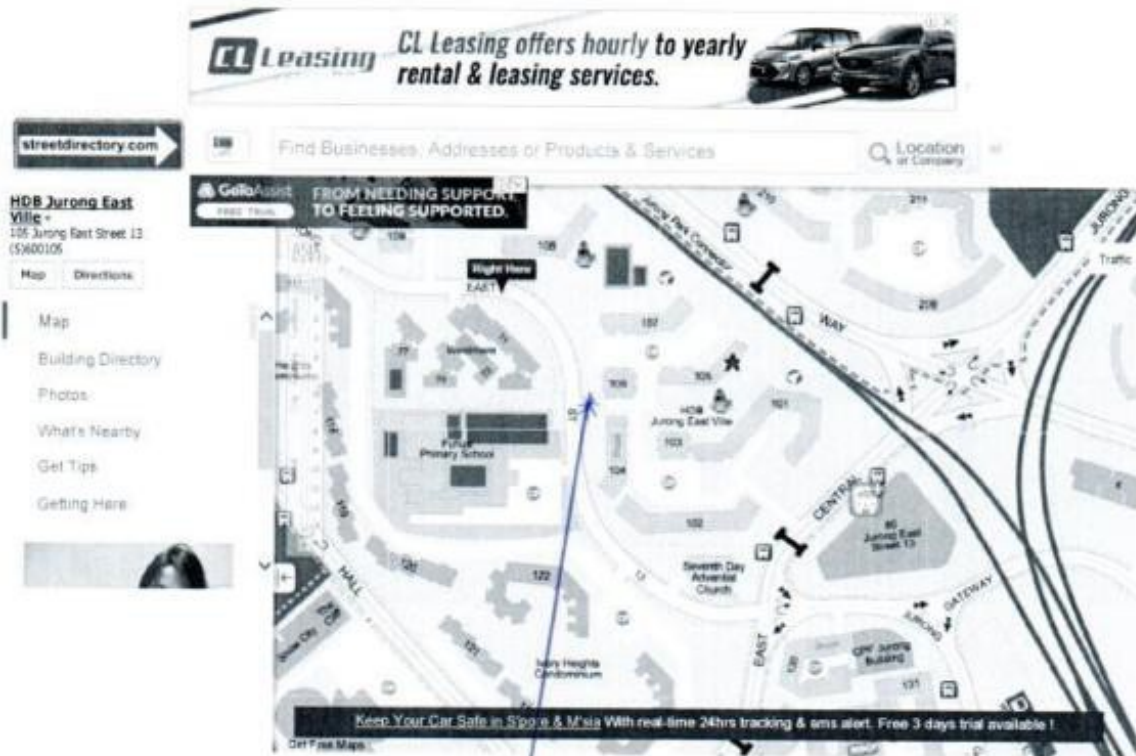

Accident Sketch Plan

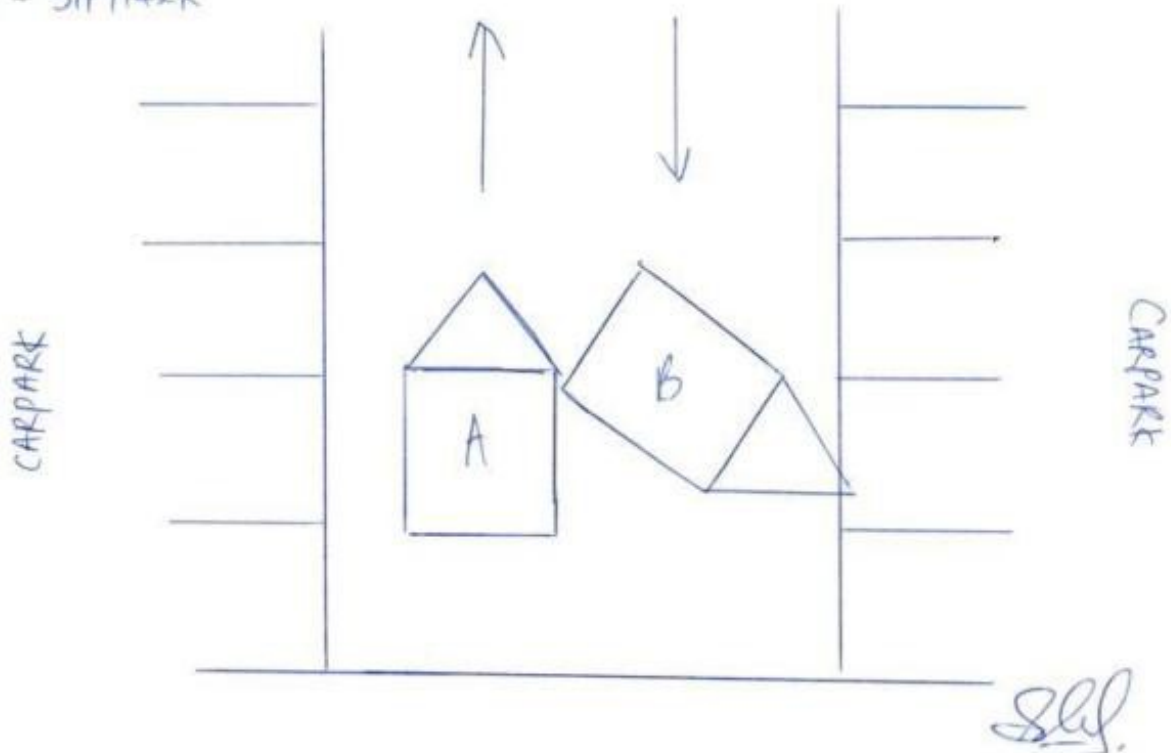
