
Sketch Plan

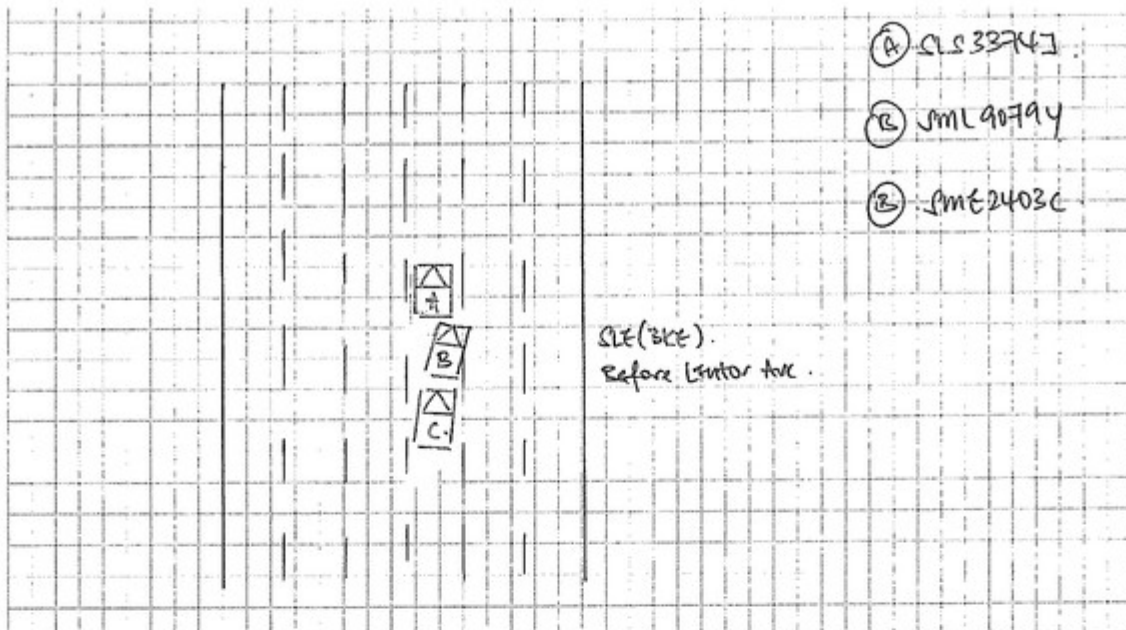
