**Brief Details.**

On 08/10/2020 at about 1347hrs, I was riding my motorbike, FBF1446K, along North Buona Vista Road, the traffic was green and I had a right of way and continue riding. When I was approaching junction of Ayer Rajah Avenue, there is a yellow color Taxi from the opposite side decided to make a right turn. I did not managed to manoeuver or brake on time as the Taxi was very close. I then collided on to the taxi left rear portion of the vehicle. Due to that impact I flew off and fell on the road. During that moment I unable to move my body and felt pain. Subsequently there is a bystander came and assisted me. The ambulance and traffic police came down to scene. I was then conveyed by ambulance to NUH. I was admitted for 5 days in the hospital and been given 19days MC. I suffered right femur broken on my right leg. I cant recall if there is any CCTV camera nearby. On 09/10/2020, I received a letter from the Traffic Police reference, TP/IP/43937/2020, TP IO: Roizman Bin Mohamed Posari, Tel: 65476131, advised me to lodge a Traffic Police report.
