2. I/We have appointed the firm of solicitors M/S of _____ to act on my/our behalf to recover damages arising out of the accident from the parties concerned.

3. I/We hereby appoint you as our agent and authorise you to do the following unde option

To undertake the necessary repairs to bring the Vehicle back to pre-accident condition. We shall pay you the costs of repair on receipt of your invoice. Thereafter, you shall liaise with our solicitors to enable us to recover the costs of repair, loss of use and all other expenses incurred.

To liaise with our solicitors to claim the costs of repair which we have incurred and the loss of use.

To liaise with our solicitors to claim for loss of use only.

To act on our behalf to claim for *Total Loss / Loss of use.

- 4. I/We hereby authorise you to claim *Third Party/Own Damaged (OD).
- 5. I/We have instructed our solicitors to obtain all instructions pertaining to the claim from your goodselves. I/We acknowledge that all instructions given to them by you will therefore be as good as if they were given by me/us.
- 6. I/We authorise you to appoint surveyors to inspect the Vehicle and to pay the Survey fee on my/our behalf prior to carrying out the repairs.
- 7. I/We leave it entirely to your discretion in accepting or rejecting any offer of settlement.

I/We have instructed our solicitors to release all monies recovered and received by them in connection with this claim after deducting their fees directly to you and to be made in the name of SC Auto Industries (S) Pte Ltd.
