We refer to the above matter.

We have met up with our insured driver Mr Yow(OID) on 21 June 2021. OID had viewed third party video footage and he adamant that there is no collision. According to OID, third party stopped his car and alighted out of his car after he drove pass our insured vehicle. Third party asked for OID IC & driving licence which OID had provided to him. After that third party just drove off. OID felt that it is weird and he keep saying that third party is cheating.

We have also inspected OID's vehicle and found that there is some damages to OI's vehicle. However OID insisted that the damages are not related to this incident. Furthermore, the damages sustained to third party vehicle is not possible caused by his vehicle. He affirmed that no collision between both vehicles.

Third party did not arrange for survey up-to-date.
