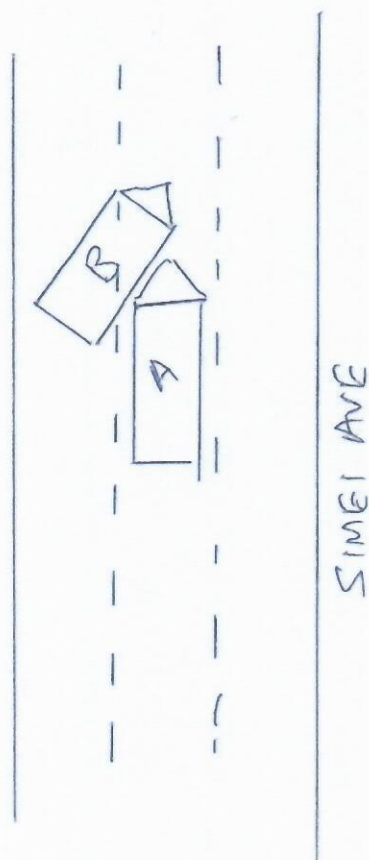
I would like to report to the Traffic Police of a case of road bully and dangerous driving. The incident took place on 29 Nov 2020 and at about 5pm, I was travelling in my car together with my wife and son along Simei Ave heading towards Xilin Ave (Singapore Export direction) when I noticed from the rear mirror a dark colour car travelling towards me from behind and came very close to my vehicle.

At that time, the traffic volume is moderate with cars travelling on all sides of the road and I was in the centre lane (out of 3 lanes). The vehicle can be seen right behind me at a close distance so my next action to warn him that he was close prompted me to tap my brakes. This is just to tell him to keep a safe distance since I was maintaining the road speed limit of 60km/h. I assumed he understood my message as he slowed down and can be seen backing off a little bit. However, it didn't last long, and the driver changed to the left lane to overtake me.

I continued with the safe speed limit but instead of him driving off, the driver swerved dangerously into my lane and knocking my car with his rear right part of his car. I was fortunate that I was driving a considerable slow speed limit and I managed to counter the impact. The car stopped in front of me and there was exchange of words. There was no assault or threat between us and to prevent escalating into any unnecessary prolonged quarrel, I told him I will be lodging a police report against his bad driving manner.

I did not take down his particulars as it to avoid any further conflict but from the car recordings, the driver of SMN5436R (Audi A5) can be seen charging towards my car direction and jerking few times to reduce his speed when approaching my car. The driver also failed to signal when he changed lane to overtake me and he deliberately swerved his car into my lane, hitting my left front on purpose. No one was injured and my car was scratched on the front left near the front left wheel.

His actions are endangering other road users' life.
