#### Brief Details.

ON 15/11/20 MY FAMILY HOSTED A DEEPAVALI PARTY AT OUR RESIDENCE (5 SWETTENHAM ROAD, S 248083) BETWEEN 6.45PM AND 8.15PM. THE PARTY WAS FOR KIDS AND HELD OUTDOORS UNDER THE CAR PORCH DUE TO THE RAIN THAT EVENING.

THE TRADITIONAL DECORATIONS INCLUDED 'DIYAS' (LIT CLAY OIL LAMPS) THAT WERE PLACED ON THE FAR EDGE OF THE PORCH.

AT AROUND 7.45PM ALL THE KIDS WENT INDOORS. AT THIS POINT, MY WIFE AND I AND OUR HELPERS BEGAN CLEANING UP THE AREA AROUND THE CAR PORCH. WE ENSURED THAT ALL THE 'DIYAS' WERE FULLY EXTINGUISHED. MY HELPER REPEATED THIS EXERCISE AROUND 8PM AND AGAIN DOUBLE CHECKED THAT ALL 'DIYAS' WERE FULLY EXTINGUISHED.

AT AROUND 8.15PM AFTER THE GUESTS HAD ALL LEFT I BEGAN MOVING MY TWO CARS BACK UNDER THE PORCH FROM THE STREET WHERE THEY HAD BEEN PARKED. AT AROUND 8.30PM AFTER PARKING BOTH CARS I WENT INDOORS. BOTH CARS WERE PARKED DIAGONALLY FACE IN UNDER THE PORCH. VEHICLE SKN3414R WAS PARKED CLOSER TO THE HOUSE AND VEHICLE SKE165B WAS PARKED FURTHER AWAY FROM THE HOUSE.

AT AROUND 8.35PM I HEARD A LOUD BANG AND MY CAR ALARM SOUNDED FROM VEHICLE REG. NO. SKE165B (WHITE PORSCHE CAYENNE). I LOOKED OUTSIDE AND SAW FLAMES COMING OUT OF THE CAR BONNET. MY FAMILY, OUR HELPERS AND I IMMMEDIATELY BEGAN PUTTING OUT THE FLAMES USING A FIRE EXTINGUSIHER, A JET SPRAY AND WATER BUCKETS. THE FIRE WAS PUT OUT WITHIN 10 MINS.

THE POLICE AND SCDF ARRIVED AT AROUND 8.45PM TO ATTEND TO THE SCENE. THEY LEFT AT AROUND 11PM WHEN THE SCENE WAS SAFE AND THEY HAD CONCLUDED THEIR OWN




