




Choa Chu Kang Crescent (Secondary Road)

**Statement of Accident**

On 03/12/20, at about 1805 Hrs, my vehicle (SGR3290<sup>9</sup>~~8~~) was travelling along Choa Chu Kang Crescent. Traffic was slow and congested due to heavy rain. Vehicle in front of me stopped. I could not stop in time and slight hit onto the rear of front vehicle (SKZ8818M). We both alighted from the vehicles to check on the damages and exchanged for particulars. Due to the light contact in the collision, no other damages found on both vehicles except the slight torn on the front licence plate of my vehicle and the rear licence plate of third party's vehicle (refer attachment). No one was injured in this accident.
