

Brief Details.
On 28/11/2020 at about 1810hrs, I was driving my company's lorry (YM8624H) along the third lane of Farrer Road. I have about 5 passengers on the lorry. I approached the junction of Holland Road and wanted to make a right turn. There was a white Toyota (5MK9554B) on the second lane and as I was making the turn, the car collided onto the right side of my vehicle. I then alighted the lorry to make a check. There was no passenger in the white car. As nobody was injured at that point of time, I told him to drive ahead as it was dangerous to stop in the middle of the traffic junction and he agreed. I drove off towards Holland Road but was later informed by my colleague that the white car drove off towards Queensway. We did not manage to exchange particulars.
There was a van that stopped and asked for my contact number as he informed that he have an in-car camera installed and the accident was recorded. On 29/11/2020 at about 0250hrs, the driver (NP-94234563), whatsapp me a footage of the accident and advised me to lodge a traffic accident report.


