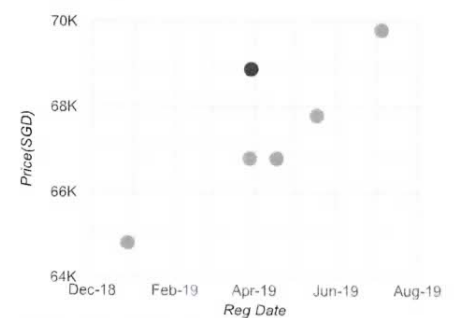


SKETCH PLAN


