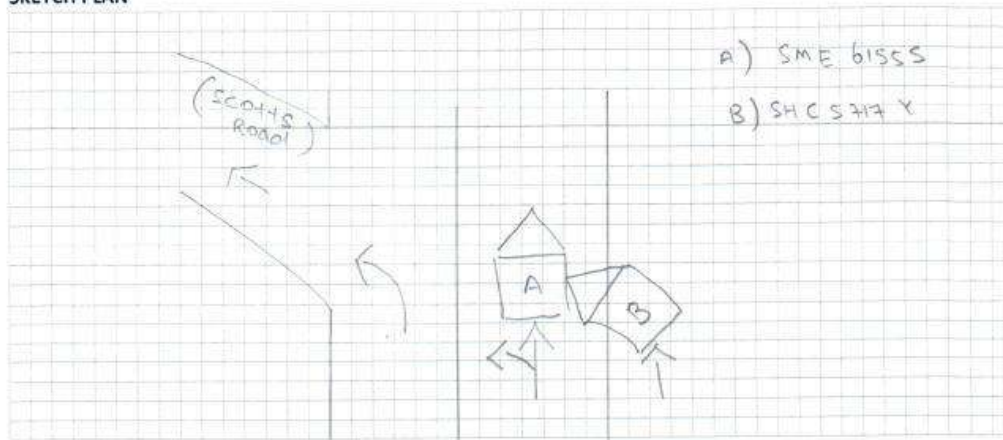

Brief Details.

On 09.12.2020 I picked up 2 passengers in my rented Grab vehicle: SME6155S from Serangoon North and headed to the destination given as Scotts Prudential. On the same day at about 1121hrs, I was driving along the roundabout of Newton Circus when suddenly a taxi bearing Registration Plate Number: SHC5717Y which was driving on the right side of my vehicle suddenly collided onto the right side of my vehicle. I believe that the driver for SHC5717Y intended to make a left turn into Scotts Road abruptly while along the roundabout.

After the accident, both my passengers are not injured and does not complain of any pain. My vehicle In-Car CCTV had captured the accident footage and I will be submitting the footage to my rental and Insurance company. I was given 5 days of Medical certificate from 09.12.2020 till 13.12.2020 after visiting a private clinic namely; "UNIHEALTH(BEDOK)" of address; Blk 214 Bedok North Street 1 #01-171 S(460214).
