Brief Details.

My vehicle registration plate number is GG3222. On 12/09/2020 at about 1600hrs, I went to my friend's company located at Eunos industrial estate for 7th month prayer. At about 2230hrs, I left my friend's company and was heading towards Geylang to have supper with my friend (Frankie). As soon as I drove out from my friend's company along Eunos Ave 3, I noticed there was a cross junction ahead. After ensuring there was no traffic on my right, I continued to travel straight ahead. At that point of time, I was travelling on one way road and there was no traffic light at the junction.

A moment later, a vehicle suddenly appeared on my right and collided with my vehicle. Due to the strong impact, I felt very dizzy after the accident. As soon as I came down from my vehicle, I fell and broke my right arm. I managed to speak to the involved driver briefly and he told me that he was okay. As the incident location was near to my friend's company, my friend "Ah Man" came out from his company and sent me to the nearest hospital. I sought medical attention at Changi General Hospital and was given with 14 days of MC from 13/09/2020 to 26/09/2020.

I did not managed to exchange particulars with the involved driver as I was feeling intense pain on my right arm and required immediate medical assistance. I did not managed to make a proper assessment on the damages on my vehicle but I noticed the front portion was badly dented.
