Brief Details.

On 07/12/2020 at about 1130hrs, I was riding along Tampines Avenue 10 towards the direction of Pasir Ris Drive 12 near IKEA Tampines in my motorcycle bearing registration plate FBG2964U. I was riding on the second lane and was switching lane to the first lane. I then signaled light indicating that I was switching lane to the right and as I was about to complete the transition to the first lane, I was hit on the right side of my motorcycle by a car bearing registration plate EP1680L. As a result of the collision, my motorcycle skidded on my right side. The driver's particulars is Marcus Ong Yong Qiang S9105309H HP: 84281243.

I would like to mentioned that I do not have any in-car camera.

I felt pain on my right side of the body as such I proceeded to Changi General Hospital where I was given 3 days of Medical Leave.
