I/We, hereby appoint you recover my damages sustained in the above accident.



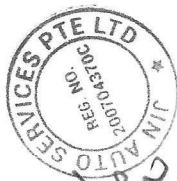
