**ACCIDENT ON 09.03.20 INVOLVING SFA 833L & SMG 487M ALONG SLIP ROAD FROM PIE
TOWARDS JALAN BAHAR**

1. We have been instructed by MSIG Insurance (S) Pte Ltd to conduct defence of their insured in connection with the above suit. The suit in question relates to a road traffic accident involving motor vehicles SFA 833L (Plaintiff) and SMG 487M (Defendant). This action is also a simplified civil action under Order 108 Rules of Court. Amongst other things, it means that a single joint expert (SJE) had to be appointed – either by agreement between the parties to this action or by appointment by the Court where there is no agreement between the parties.
2. In this case, the Court had appointed **Kong Seng Cheong** of LKK Auto Consultants Pte Ltd to be the SJE. As an expert (being a licensed surveyor), you will be required of the following:

- 2.1. Write a survey report by 15 January 2021 as to the quantum for repairs and give an estimation of the duration of repairs.
- 2.2. If you however take the view that it will not be economical to repair the vehicle, then, please state so and elaborate the basis for such a view i.e. provide the estimates of the market value of the vehicle less the rebates.
- 2.3. Conduct a physical inspection if you are of the view that it is necessary.
- 2.4. As you are the appointed expert, please remember to state in your written report that you understand that in giving your report, your duty is to the Court and that you have complied with that duty.
