NOTICE OF REPORTING

This is to confirm that Chan Kah Mun, NRIC/FIN S7806378E, has reported to the Police a non-injury traffic accident which occurred at Rangoon Road on 10/12/2020 at 1220hrs involving the following vehicles:

V1) SFF99M (Informant)
V2) FBH8995K

Facts:

On the above-mentioned date and time, I was driving along Rangoon Road on the first lane. I was the first vehicle waiting to turn to the right, but I decided to change lane to go straight instead. I did not see the rider overtake me and was in front of my vehicle as he was initially on my left lane. As I was about to turn left to go straight, I pressed on my pedal and knocked onto a vehicle in front of me bearing registration plate no FBH8995K causing the rider to fall off. However, he did not suffer any injuries. My mother-in-law was present with me at that point of time when I asked the rider if he was fine.

I exited from my vehicle to inspect the damage. The motorcycle's rear registration plate was broken, and his box had fallen off due to the impact. As for my vehicle, there were dents and scratches on the middle part as well as my front registration plate. I took photographs of the damages and exchanged particulars with the rider. I wish to state that my vehicle does not have any built-in camera. I am lodging this for record purposes.

2 If this accident was reported to the Police within 24 hours of its occurrence, then he/she has complied with Sec 84(2) of the Road Traffic Act, Cap 276.
