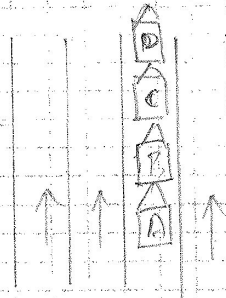
SKETCH PLAN
